



*2020 Town of Westport Road Improvements
Auchter Lane Reconstruction*

The reconstruction of **Auchter Lane** is scheduled to begin soon as the work on Maria Way winds down. We anticipate completion of the work in approximately 3-5 weeks, weather permitting. The project has been publicly bid and the Town Board has awarded the project to Raymond P. Cattell, Inc., from Madison, Wisconsin.

For the safety of the workers, we ask that you please be aware of the construction equipment and workers and limit the use of the road during construction hours (7am – 7pm).

The contractors will remove the existing asphalt pavement and the existing base material, rebuild the road base, and grade the road, in preparation for the new asphalt surface. The roadway will remain open to vehicular travel throughout the project. However, vehicles may encounter lane restrictions and possible brief delays during the construction. The Contractor will make every effort to provide access to private driveways for residential driveways during the project and at the end of each day. However, there may be short periods of time when vehicle access to your property may not be possible.

In preparation for the construction we ask that any landscaping or private underground utilities (such as an invisible dog fence, lawn sprinkling systems, special soils, decorative fencing, etc.) that may be located within the construction area or immediately adjacent to the existing road, be removed and salvaged by the property owners. If you are not sure if they will interfere with the construction, please contact us.

In order to ensure regular U.S. Mail deliveries, the Postmaster has instructed the contractor to install a temporary mailbox station **located on Riveredge Road just east of Maria Way. Please watch for additional information to be posted on the mailbox station. Deliveries to the temporary mailbox station will begin when the construction starts on your road.** The existing permanent mailboxes may be removed to accommodate the construction. If so, they will be removed and placed on your lawn. Please store them away for safe keeping until contractor is ready to re-install them (towards the end of the construction). If you would like to replace your existing mailbox post, please purchase a new one and make it available to the contractor, and they will re-install them. Please contact the post office if you have any questions regarding specific mail deliveries.

All lawn and terrace areas that are disturbed during the construction will be restored with grass seed. We ask that you please water and maintain these areas as needed after they are restored to promote new growth.
